c. The avoidance of unnecessary proof and cumulative evidence;

d. The identification of witnesses and documents, the need and schedule for filing and exchanging pretrial briefs;

e. The disposition of pending motions;

f. The need for adopting special procedures for managing potentially difficult or protracted actions, complex issues, multiple parties, or unusual problems;


g. Establishing a reasonable limit on time allowed for presenting evidence; and
