NOTICE IS HEREBY GIVEN that the Public Auditor is reversing December 31, 2020, and March 1, 2020, Recusals and Orders Appointing and Designating Hearing Officer Anthony R. Camacho to Preside Over the referenced consolidated appeals.

I. Facts

On December 16, 2019, Basil Food Industrial Services Corporation ("Appellant") filed a Notice of Appeal relative to the procurement of Nutrition Services for the Comprehensive Management, Operations, and Maintenance of the Elderly Nutrition Program, Congregate Meals and Home-Delivered. The Office of Public Accountability ("OPA") assigned this appeal case no. OPA-PA-19-011

On December 26, 2019, the law firm of Civille & Tang, PLLC, through Attorney Joyce C.H. Tang filed a Notice of Entry of Appearance on behalf of interested party S.H. Enterprises, Inc.

On December 31, 2019, the Public Auditor issued the Recusal and Order Appointing and Designating Hearing Officer Anthony R. Camacho to Preside Over the appeal, to avoid the appearance of impropriety caused by his social relationship with Ms. Tang.

On February 27, 2020, the Appellant filed a second appeal relative to the same procurement in OPA-PA-19-011, and the OPA assigned this appeal case no. OPA-PA-20-003.

On March 1, 2020, the Public Auditor issued the Recusal and Order Appointing and Designating Hearing Officer Anthony R. Camacho to Preside Over the appeal, citing the same conflict with Ms. Tang representing the interested party.

On March 13, 2020, Hearing Officer Camacho issued the Order Consolidated appeals OPA-PA-19-011 and OPA-PA-20-003.

II. Basis for Reversal of Recusal and Appointment of Hearing Officer to Preside Over Appeal

On February 14, 2020, the Law Office of Vanessa L. Williams, P.C., through Attorney Vanessa L. Williams filed a Substitution of Counsel in place of the law firm of Civille & Tang, PLLC in representing the interested party.

On July 7, 2020, the Appellant filed a Notice of Disqualification of Procurement Appeals
Hearing Officer Anthony Camacho, citing Hearing Officer Camacho's employment as Legal
Counsel for the University of Guam and serving as a contracted Hearing Officer for the OPA

violates 5 G.CA. §30113, which states that governmental attorneys shall not engage in private practice.

Therefore, since the law firm of Civille and Tang, PLLC is no longer representing the interested party and because the Appellant has requested Hearing Officer Camacho be disqualified, the Public Auditor has decided to reverse his recusal and appointment of Hearing Officer Camacho and regain his authority to preside over the referenced consolidated appeals.
