I. JURISDICTION

- B. Whether Appellant waived its rights in the knowledge of specifications and that "feedback" was requested.
- C. Whether the Qualified Products List, produced from multiple small purchases from multiple using agencies without incident was arbitrary or unreasonable.

D. Whether the annual GSA updates and ability of using agencies to complain about or suggest container sizes at any time increases or decreases the validity of this Qualified Products List.
