Form and Filing:

- 1. On July 31, 2015, GSA issued an Invitation for Bid, GSA-093-15 ("the IFB"), for "Miscellaneous Items & School Bus Parts".
 - 2. On August 25, 2015, four bidders responded to the IFB and all bids were opened.
- 3. A Bid Status document, dated September 28, 2015, was provided to MPFE indicating that MPFE's bid had been rejected due to "[n]o bid security or insufficient bid security." *See* Exhibit "A". The Bid Status further remarked: "Standby Letter of credit in the amount of \$42,000.00 (Bid security short by \$2,263.41) Total Amount of Bid Amount: \$295,089.37." *Id.*
- 4. The price list per vendor received from GSA indicates that MPFE had mistakenly transposed the decimal in the price per foot in Line Item 79.1, described as "HEATER HOSE (3/4 Inch Inner Diameter) 50 feet Roll". *See* Exhibit "B". As a result, the price per foot incorrectly read as \$537.00 per foot instead of \$5.37 per foot. The only other bidder on Line Item 79.1 was Morrico Equipment, LLC ("Morrico"), which indicated a price per foot of \$9.04. Despite the error in the price per foot, the total price per roll was correctly entered at \$268.50 per roll. This price was \$183.50 lower than Morrico, the next lowest bidder, which bid a price per roll of \$452.00.
- 5. On information and belief, GSA used the mistakenly entered price per foot of \$537.00 and multiplied that figure by 50 to obtain its own price of \$26,850.00 per roll, despite the per roll price of \$268.50 entered by MPFE. GSA then combined its \$26,850.00 per roll price with MPFE's extended prices for all Line Items in the IFB and came to its own total bid price for MPFE of \$295,089.37. GSA then rejected MPFE's bid on the basis that the \$42,000.00 standby letter of credit provided by MPFE was insufficient to cover the new total bid price GSA had calculated for MPFE based on the obviously mistakenly entered per foot price of \$537.00.
- 6. As a result, it appears that all of the line items for which MPFE was the lowest bidder will be awarded to the next lowest bidder instead.

- 7. The original protest made by MPFE was made on September 28, 2015. *See* Exhibit "C". In the protest, Craig Wade, the President/CFO of MPFE, disagreed with GSA's determination that MPFE's bid bond was insufficient. Mr. Wade noted that MPFE's extended prices totaled \$268,507.87, not \$295,089.37 as erroneously calculated by GSA.
- 8. GSA responded to MPFE's protest in a letter dated September 29, 2015. See Exhibit "D". There, GSA denied the protest, noting that "[i]n reviewing your bid submittal, there was no evidence that a mistake occurred."
- 9. MPFE is appealing GSA's decision on MPFE's protest on the basis that it is evident on the face of MPFE's bid that the price per foot for Line Item 79.1 entered by MPFE was a mistake and that the intended correct bid is clearly evident on the face of MPFE's bid given the price per roll of \$268.50 which was entered right next to the mistaken figure.
 - 10. 2 GAR Division 4 Section 3109(m)(4)(C) states that:
 - (C) Mistakes where intended correct bid is evident. If the mistake and the intended correct bid is clearly evident on the face of the bid document, the bid shall be corrected to the intended correct bid and may not be withdrawn. Examples of mistakes that may be clearly evident on the face of the bid document are typographical errors, errors in extending unit prices, transportation errors, and arithmetical errors.
- 11. MPFE's position is that the \$537.00 per foot price entered in Line Item 79.1 was clearly a typographical error. This is supported by the fact that the \$268.50 price per roll entered in MPFE's bid is the product of \$5.37 multiplied by 50 feet, the fact that the only other bidder for Line Item 79.1 bid \$9.04 per foot, and the fact that the \$42,000.00 standby letter of credit is sufficient if the price per roll entered by MPFE is used to calculate the total bid amount instead of the price per roll calculated by GSA.
- 12. GSA's decision to exacerbate the typographical error by using it to calculate an absurdly disproportionate price per roll and then reject MPFE's bid in its entirety was improper given the rule on mistakes set forth in 2 GAR Division 4 Section 3109(m)(4)(c).

one of the underlying principles and policies of the Guam Procurement Law is "to provide increased economy in territorial activities and to maximize to the fullest extent practicable the

GSA's decision is also improper given 5 G.C.A. §5001(b)(5), which provides that

purchasing value of public funds of the Territory." GSA's decision to reject MPFE's bid based on

a mistake that was obvious on the face of the bid will result in an award for every line item for

which MPFE was the lowest bidder to other parties with higher bid prices. This will result in a

larger overall cost to the government of Guam.

14. MPFE requests that the Office of the Public Auditor determine that the \$537.00 per

foot price was clearly a mistake, determine that the intended correct bid price was clearly evident

on the face of the bid document, order that the bid document be corrected to the intended correct

bid of \$5.37 per foot, and overturn GSA's rejection of MPFE's bid on the basis of insufficient

security.


