7 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
8 from the Hearing Officer on the admissibility of evidence;
9 c) The avoidance of unnecessary proof and of cumulative evidence;
10 d) The identification of witnesses and documents, the need and schedule for filing
11 and exchanging pretrial briefs;
12 e) The disposition of pending motions;
13 f) The need for adopting special procedures for managing potentially difficult or
14 protracted actions, complex issues, multiple parties, or unusual proof problems;
15 g) Establishing a reasonable limit on the time allowed for presenting evidence; and
16 h) Such other matters as may facilitate the just, speedy, and inexpensive disposition
17 of the action.
