Dear Madam Attorney General,

On or about 30 September 2013, the Guam Visitors Bureau (GVB) entered into a contract with TLK Marketing Co., Ltd. (TLK) for Tourism Destination Marketing Services in the Republic of Korea. On 25 November 2015 the GVB issued a Request for Proposals (GVB RFP 2016-006) to continue these services. TLK submitted a proposal in that solicitation and was determined to be the second highest ranked offeror. TLK objected to the result of the solicitation, filed a protest, and the matter is now on appeal before the Office of Public Accountability (OPA-PA-16-003 and 005).

In the course of the protest and appeal (as well as before), GVB came into possession of information that TLK had disregarded certain contract requirements and had made misrepresentations, which caused GVB to pay over money that was unearned. As a result, I believe there is probable cause to find that TLK's actions constitute a serious breach of contract as well as civil and criminal fraud. Accordingly, I am considering suspending and debarring TLK from participation in Government of Guam procurements in accordance with 5 Guam Code Ann. §5426 and 2 Guam Admin. R. & Reg. §9102.

As you know, both statute and regulation instruct the head of a purchasing agency to consult with the Attorney General prior to initiating action to suspend or debar. See 5 Guam Code Ann. \$5426(a), "After reasonable notice to the person involved and reasonable opportunity for that person to be heard, the Chief Procurement Officer, the Director of Public Works or the head of a purchasing agency, after consultation with the using agency and the Attorney General, shall have authority to debar a person for cause from consideration for award of contracts" and see also 2 Guam Admin. R & Reg. \$9102. Accordingly, I write to arrange a time and place to meet and consult with you or your designee prior to taking agency action. Thank you for your attention in this matter and I look forward to your response at your earliest convenience.
