**BASIL FOOD INDUSTRIAL SERVICES
CORPORATION'S OBJECTIONS TO
WITNESS LIST AND EXHIBITS**

Appellant Basil Food Industrial Services Corporation registers the following objections:

1. Basil objects to GSA's witness Joshua J.A. Mafnas of the Department of Corrections. Basil holds an unrelated food services contract with DOC, which is wholly separate from and irrelevant to these proceedings. In no place in GSA's Termination Letter (see Ex. 18) did GSA cite Basil's performance under the DOC contract as part of its termination consideration. GSA is improperly seeking to introduce irrelevant and unrelated issues to justify its defective termination. Basil asks that Mr. Mafnas not be permitted to testify.

2. Basil objects to GSA's Supplemental Exhibit F. Exhibit F is untimely: it was not part of the procurement record and furnished after the exhibit deadline passed. Since Exhibit F was purportedly recorded by Mr. Mafnas, it would be related to Basil's DOC contract, and not the Contracts at issue in this proceeding.

3. Basil objects to GSA's Exhibit B which was not contained within the procurement record, and withheld from Basil in response to Basil's FOIA requests.


4. Basil objects to the portions of GSA's Exhibit C which were not contained within the procurement record, or withheld from Basil in response to Basil's FOIA requests.

5. Basil objects to GSA's Exhibit D which was not contained within the procurement record.

6. Basil objects to GSA's Exhibit E which was not contained within the procurement record and formed no part of GSA's termination decision.
