Attached is a revised draft. The introductory paragraph correctly references Lease Financing, Design and Maintenance however such were omitted in Section No. 1. DPW's proposed revisions are high lighted and are consistent with Sections 58D102 and 58D105 of PL 32-120. DPW has italicized the last proposed sentence of Section 1 and respectfully requests that it be deleted.

The Stipulation should be limited to the current RFP, and not issuance of a 2nd RFP. In this respect, the Stipulation clearly recites that the current RFP will not solicit services for insurance and maintenance of Guam's other 34 public schools. PL 32-120 does not direct issuance of a 2nd RFP and we doubt the Hearing Officer will allow such in the Stipulation. If DPW's proposed revisions are acceptable to Core Tech please forward a finalized Stipulation to me for signing by my office and DPW's Deputy Director.
