**THOMAS P. KEELER** makes this declaration under penalty of perjury under the laws of Guam and states:

- 1. I am employed as an Assistant Attorney General by the Office of the Attorney General of Guam.
- 2. The Guam Department of Public Works ("DPW") Highway Division has been ordered to supplement the procurement record in this matter by Wednesday, December 20, 2017.

3. DPW, its consultants, Parsons Transportation Group ("PTG") and WSP USA, Inc. f/k/a Parsons Brinkerhoff ("WSP"), and the Guam Office of the Attorney General have diligently reviewed their respective records and are submitting all records in their possession, with the possible exception of one item.

4. At or about the time of award of contract it is my understanding that the Office of the Attorney General was provided sealed escrow documents ("Sealed Escrow Documents") for safe keeping.

5. I am informed that the Sealed Escrow Documents contain Core Tech International Corp.'s ("Core Tech") pricing information.

6. DPW, its consultants, and the Office of the Attorney General have made a good faith effort to locate the Sealed Escrow Documents but have been unable to locate them.

7. Although DPW is not able to produce the Sealed Escrow Documents such does not prejudice Core Tech as Core Tech is already in possession of said documents.
