
As director of the Bureau of Women's Affairs, I have not had the opportunity to procure any items for BWA before the implementation of the Government of Guam's FY 2022 budget, which became effective October 1, 2021. I have contacted Ms. Kimberly Taitano, Program Specialist, Professional Development, at the Guam Community College Office of Continuing Education (735-5574, kimberlyann.taitano@guamcc.edu), as to when the next procurement training will take place. Ms. Taitano has kindly agreed to inform me of the next training availability, for which I will then register and complete Modules 1 and 2, per 5GCA §5141(n).

Please note that the staff of the Governor's Community Outreach Federal Programs Office does not procure or handle any local funding. They are paid for with, and disseminate to subgrantees, U.S. Department of Justice (USDOJ) Office of Violence Against Women (OVW) Services*Training*Officers*Prosecutors (STOP) and Sexual Assault Service Providers (SASP) grant funding, and funding from our recently awarded Increasing Criminal Justice Responses (ICJR) grant. All of these grants deal specifically with services for victims of, and law enforcement handling of the perpetrators of, the crimes of domestic violence and sexual assault. USDOJ requires specific grant financial management training sessions for all of these grants, and the administration and staff of GCOFPO are in full compliance with these trainings.
