18           without prejudice to any subsequent objections.

- 20           1. GPA issued MS IFB GPA-061-20 in 2020.
- 21           2. GPA awarded Dooik, then canceled the bid to change the specifications.
- 22           3. Dooik protested the cancellation, then withdrew its protest.
- 23           4. GPA issued MS IFB GPA-023-23 on or about January 12, 2023.
- 24           5. Dooik submitted its proposal on or about March 8, 2023.
- 25           6. Dooik was notified of its unacceptable score on or about May 23, 2023.
- 26           7. Dooik protested its failure to pass Step 1 on or about May 30, 2023.
- 27           8. GPA denied Dooik's protest on or about September 6, 2032.
- 28           9. Dooik appealed to the OPA on or about September 18, 2023.

1           10. GPA issued a stay of the procurement in MS IFB GPA-023-23 on or about  
2           September 18, 2023.
