RE: Freedom of Information Act Request

Mr. Ada,

In reviewing the Administrative Record your counsel submitted as required under OPA -PA-13-007, and received by our office on 6/21/13, I noticed there appears some missing documentation. On several occasions I was informed by you and members of your management team that your offices were waiting for legal review of Able's letters requesting consideration for non-bid award of the terminal custodial contract.

Such documents between airport management and legal counsel are rightfully part of the administrative decision process regarding contract award and as such should have been included in the administrative record submitted by Fisher & Associates as part of the Office of Public Accountability (OPA) review process; but unfortunately I did not see any of the referenced documents in my copy of the documents submitted to the OPA.


I also noticed that several documents between Guam International Airport Authority (GIAA) and Able Industries of the Pacific (AIP) are missing. I also noticed that attachments to several of the documents presented in the administrative record submitted by GIAA counsel Fischer & Associates are missing, thus making the submission to OPA an "incomplete" Administrative Record.

I am very concerned about the potential adverse impact the missing documents, emails, and/or attachments that are legally part of the administrative record could have on the outcome of our appeal. Therefore I am requesting copies of any and all correspondence and copies of any and all emails regarding Able Industries request under GCA 5001 (d) and GARR 3110.1 for a non-bid award of contract under the Freedom of Information Act (FOIA).

In view of the tight schedule for the review of OPA-PA-13-007, I am also again requesting under FIOA, copies of the missing documents and attachments to existing documents also be provided to complete the Administrative Record as soon as possible to ensure the OPA has a complete set of documentation upon which to begin the review process.
