Please be advised that IP&E Holdings, LLC (IP&E) filed an appeal with the Office of Public Accountability (OPA) on August 22, 2014 regarding the Guam Power Authority (GPA) procurement actions related to GPA 029-14 for the Invitation for Bid of the Supply of Diesel Fuel Oil No. 2 for Baseloads and Peaking Units. OPA has assigned this appeal case number OPA-PA-14-008.

Immediate action is required of GPA pursuant to the Rules of Procedure for Procurement Appeals, found in Chapter 12 of the Guam Administrative Regulations (GAR). - A) Guam Power Authority (“GPA”), Consolidated Commission on Utilities (“CCU”).
- B) Invitation for Bid NO. GPA 029-14 for the Supply of Diesel Fuel Oil No. 2 for Baseloads and Peeking Units.
- C) Decision being appealed is the GPA Denial of Protest, dated August 15, 2014.
- D) Appeal is made from a decision on protest of notice of award.
- E) Names of Competing Bidders: Mobil Oil Guam, Inc.

Form and Filing:

On or about March 13, 2014, GPA issued invitation for bid GPA -029-14 for the procurement of diesel fuel for various GPA power plants. Bid opening occurred on July 8, 2014.

Section 4.3 of the IFB addressing award provides that "GPA will award the Contract to the BIDDER whose proposal yields the lowest overall Contract price for the contract base year period." The relevant portions of the IFB are attached as Exhibit A. .

Based on the Bid Abstract it appears that bids were submitted by Mobil Oil Guam Inc. and IP&E. A copy of the bid abstract is attached as Exhibit B. On or about August 15<sup>th</sup>, GPA provided IP&E a Notice of Intent to Award to IP&E for the Tenjo Site (Exhibit C). GPA also provided IP&E its Rejection of Bid concerning the Dededo Diesel and CT Plants. (Exhibit D).

In a letter sent by email to GPA on August 12, 2014, IP&E filed an agency protest with GPA challenging the award methodology since IPE submitted the overall lower cost but was only awarded the contract for the Tenjo location. (Exhibit E) GPA denied the protest via letter dated August 15, 2014. (Exhibit F).

It is IP&E position that GPA's denial of its protest is incorrect and that the OPA should direct award of the overall contract to IP&E. Section 4.3 Proposal Evaluation clearly provides that "GPA will award **the** Contract to **the** BIDDER who proposal yields the lowest overall CONTRACT base year period." Emphasis supplied.

In its response to the IP&E protest GPA argues that it may make multiple awards based on Section 2.13 which states that the "Contract will be awarded in whole or in per plant location to the BIDDER evaluated as being qualified and with the best-price proposal." The balance of Section 2.13, as well as Section 4.3 only references award to a single Bidder and does not provide for multiple awards.

Based on GPA's bid abstract, the IP&E Bid for all sites was \$16,949,400 and other bid amount was \$17,097,00. Thus, IP&E's overall contract price was \$147,600 lower than the other bidder per year and \$442,800 lower over the term of the contract.


As the IFB did not provided for the award of multiple contacts and stated that award would be made to " **the** Bidder whose proposal yields the lowest overall Contract base year period" GPA should have made contract award to IP&E for the entire contract and for this reason the proposed award should be suspended until the protest is resolved. Had GPA intended to ~~make multiple awards it should have explicitly provided for in the IFB as it would have impacted~~ bidders' pricing strategy.

Declaration regarding court action:

IP&E confirms that an action in court has not been commenced.



**2.12.5. Evaluation Criteria and Comparison of Priced Offers**

GPA will evaluate and compare the Priced Offers for Bidder's Technical Proposals that were determined during Step One to be responsive to the tender document requirements. The Scoring Mechanism is further explained in Section Four.

**2.13. Award of Contract**

The contract will be awarded in whole or per plant location to the BIDDER evaluated as being qualified and with the best-priced proposal.

The successful BIDDER will be notified by GPA through official written correspondence of the intent to award the contract (Notice of Intent to Award). The written correspondence may be sent by GPA via official letter, e-mail and fax.

The BIDDER will be required to send to Guam, within fourteen (14) days of the date of receipt of such notice, a representative or representatives with proper Power-of-Attorney for the purpose of executing a contract with such alterations or additions thereto as may be required to adopt such contract to the circumstances of the proposal. The successful BIDDER shall provide the required Performance Bond within fourteen (14) working days of receipt of the GPA Notice of Intent to Award.

Failure on the part of the successful BIDDER to provide a Performance Bond and/or to enter into a contract with GPA shall be sufficient grounds for the annulment of the award. GPA may determine the bidder to be non-responsive to the bid, and may proceed with sending a Notice of Intent to Award to the next most qualified BIDDER.

**2.14. Bid Bond and Performance Bond Requirements****2.14.1. Performance Bond Form, Amount and Duration**

The required performance bond shall be in the form as prescribed in Appendix B. At the beginning of the CONTRACT and at the beginning of each GPA Fiscal Year during which the CONTRACT is in effect, the CONTRACTOR shall provide and maintain a performance bond in the amount equivalent to one hundred percent (100%) of the annual contract cost for that full or partial fiscal year within the term of the contract. If the CONTRACTOR is declared by GPA to be in default under the CONTRACT, GPA may exercise

- Acceptable
- Potentially Acceptable
- Unacceptable.

The Procurement Officer or his designee may initiate Step Two if there are sufficient acceptable Unpriced Technical Proposals to assure effective price competition in the second phase without technical discussions. If the majority of the GPA evaluators rate the BIDDER as Acceptable , that BIDDER is determined to be Qualified and will be allowed to participate in Step 2– Price Proposal.

If the Procurement Officer or his designee finds that such is not the case, the Procurement Officer or his designee shall issue an amendment to this Invitation for Bid or engage in technical discussions with BIDDERS who are rated by a majority of the GPA evaluators as Acceptable or Potentially Acceptable. During the course of such discussions, the Procurement Officer or his designee shall not disclose any information derived from one Technical Proposal to any other BIDDER.

Once discussions are begun, any BIDDER who has been notified that its Offer has been finally found acceptable may submit supplemental information amending its Technical Proposal at any time. Such submission may be made at the request of the Procurement Officer or upon the BIDDER’s own initiative.

BIDDERS who are rated by the majority of the GPA evaluators as Unacceptable is determined to be Not Qualified and will not be allowed to participate in Step 2– Price Proposal. The Procurement Officer shall record in writing the basis for finding a Bidder Not Qualified and make it part of the procurement file.

**4.3. Price Proposal Evaluation**

GPA will award the Contract to the BIDDER whose proposal yields the lowest overall CONTRACT price for the contract base year period.

### **5.1. Definitions**

Wherever used in these General Conditions or in the other Contract Documents, the terms used have the meanings indicated which are applicable to both the singular and plural thereof.

### **5.2. Accounting**

For accounting purposes and for use in establishing property records, GPA may require CONTRACTOR to provide a reasonable price breakdown of the total price into separate prices applying to the individual items supplied under the Agreement.

### **5.3. Documentation**

GPA shall have the right to reproduce any prints, or other data or documents received from CONTRACTOR.

### **5.4. Language and Trade Terms**

All communications, documents, and execution of services hereunder, unless otherwise designated, shall be in the English language. INCOTERMS (International Rules for the Interpretation of Trade Terms) published by the International Chamber of Commerce in 1980 and any subsequent revisions thereto shall govern interpretation of trade terms in the Contract Documents

### **5.5. Release of Information**

The CONTRACTOR shall not release any information including the contract price concerning this project or any part thereof in any form, including advertising, news releases, or professional articles, without written permission of GPA.

### **5.6. Limitations of Clause**

Nothing herein contained shall excuse the CONTRACTOR from compliance with any rules of law precluding GPA and its officers and any CONTRACTORS from acting in collusion or bad faith in issuing or performing change orders that are clearly not within the scope of the contract.




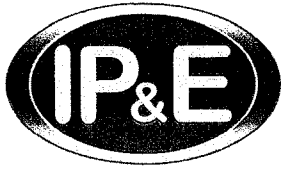

As outlined in the following table IP&E's total contract price is lower by \$147,600 per annum or \$442,800 per the contact period when compared to the other bidders offer.

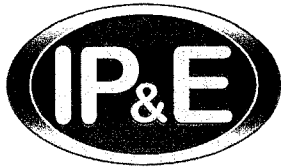

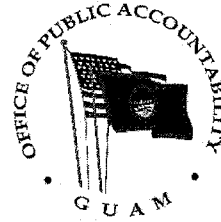
