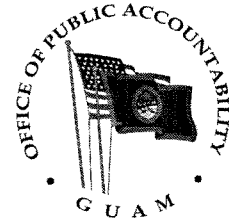

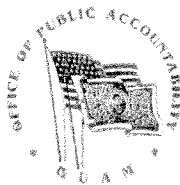

Order After Hearing/ Scheduling Order

On August 26, 2013, a Prehearing Conference was heard before Public Auditor Doris Flores Brooks and Hearing Officer Peter C. Perez, Esq. Joshua D. Walsh, Esq. and Joseph C. - 2 6. The hearing on this appeal shall commence at 9:00 a.m., Wednesday, September 25, 2013,
- 3 at the Public Auditor's hearing room, Room 907, DNA Building, Hagatna, Guam.
- 4 7. It is further ordered that GMHA shall serve a copy of this Order After Hearing/Scheduling
- 5 Order upon each other person or company who submitted a bid, in order that any one of
- 6 the other bidders may seek to participate in this appeal as an interested party.
- 7 8. It is ordered that GMHA file with the Public Auditor a proof of service of the Order After
- 8 Hearing/Scheduling Order and that it served in accordance with the immediately
- 9 preceding paragraph. The responsibility to serve a copy of the Order After
- 10 Hearing/Scheduling Order on the other bidders is imposed upon GMHA because it is the
- 11 entity that is most likely to have the correct names and addresses for such competing
- 12 bidders.
