A Status Hearing was held on July 10, 2012 before Hearing Officer Phillip Torres, with each of the parties and their representatives present. At said hearing the following was ordered:


1. Discovery cut off shall be **August 14, 2012**.

2 4. The formal Hearing shall be held on **September 6, 2012 at 9:00a.m.**

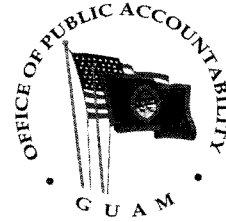
