

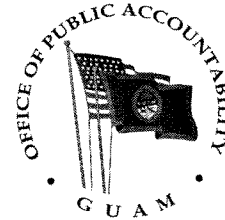
It is **SO ORDERED**. The General Services Agency shall have until May 15, 2012 to file the Rebuttal to Comments of the Appellant.
