Pursuant to the Scheduling Order for Hearing Re Appellant's Appeal dated November 13, 2013, the Guam Department of Education ("GDOE") hereby submits its Admissions of Fact.

1. G4S Security Systems (Guam) Inc. ("G4S") submitted a bid in response to GDOE Invitation for Bid 032-2013 ("IFB") for the Design Build Fire Alarm System Upgrade/Replacement and Fire Suppression/Sprinkler System Repair for Southern High School.

2. GDOE determined that G4S' bid was nonresponsive because G4S failed to include an Acknowledgement of Amendment 2 in its bid submission.

3. G4S filed a protest with GDOE on September 16, 2013 regarding the IFB.

4. GDOE responded to the protest by letter dated September 19, 2011.

5. On October 3, 2013, G4S filed its Notice of Appeal.

6. On October 4, 2013 G4S filed its Motion to Declare Automatic Stay in Effect.

7. On October 11, 2013 GDOE filed its Submission of Procurement Record.

8. On October 21, 2013 GDOE filed its Submission of Agency Report.

9. On October 29, 2013, G4S filed its Comments on Agency Statement.

1 10. On November 12, 2013, the Office of Public Accountability (“OPA”) issued a
2 Decision and Order granting G4S’ Motion to Declare Automatic Stay in Effect and voided GDOE’s
3 award of the contract to Orion Construction Corporation (Guam) Inc.

7 12. On November 20, 2013, G4S filed its Response to Agency’s “Status of
