25 hereby FINDS and ORDERS the following:


- 26 1. Testimonial evidence adduced at the formal hearing in this matter held on August 20,

2 did not place them in the public portions of the IFB's Procurement Record.

3 2. The Purchasing Agency is hereby ORDERED to file with the OPA, no later than 5:00  
4 p.m., on September 4, 2015, any and all documents that bidders submitted in response to the IFB  
5 which were marked as "Confidential," or "Propriety" or marked in any such other manner  
6 whereby GPA did not place them in the public portions of the IFB's Procurement Record.

7 3. The documents the Purchasing Agency files in response to this ORDER shall be  
8 SEALED and shall be reviewed *In Camera* unless the Purchasing Agency files a statement  
9 advising the OPA that such documents do not exist.
