SCHEDULING ORDER


On September 10, 2015, a Pre-Hearing Conference was heard before Public Auditor Doris Flores Brooks and Hearing Officer Delia Lujan Wolff. Attorney Phillip Torres appeared on behalf of Appellant Maeda Pacific Corporation (“Maeda”) and Attorney Vanessa L. Williams appeared on behalf of the Guam Solid Waste Authority (“GSWA”). The Public Auditor ORDERS:

1. The deadline for Maeda to file an opposition to GSWA’s Motion to Dismiss for Lack of Jurisdiction and for Recusal is September 17, 2015.
2. The deadline for GSWA to file a reply to Maeda’s opposition is September 24, 2015.
3. The hearing on GSWA’s Motion to Dismiss for Lack of Jurisdiction and for Recusal is set for October 23, 2015, at 10 a.m., at the Office of Public Accountability’s Procurement Appeals Hearing Room, Room 907, DNA Building, Hagåtña, Guam.
4. The parties shall file the following materials by October 19, 2015:
 - a. Formal hearing briefs stating the parties’ respective positions supported by applicable authorities;
 - b. A statement of stipulated facts;
 - c. Witness lists;
 - d. Exhibit lists; and
 - e. Pre-marked hearing exhibits.

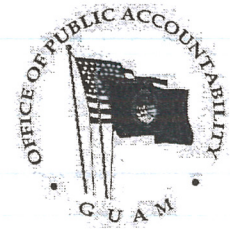

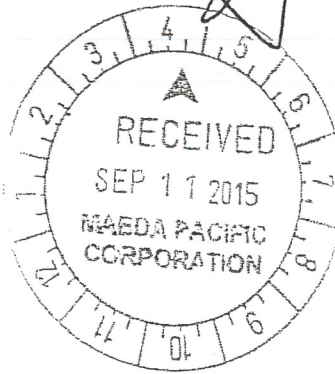

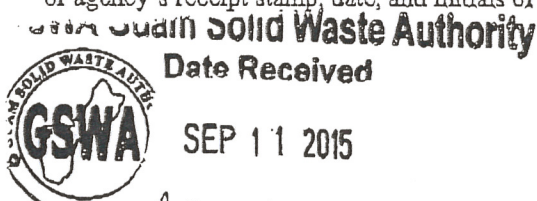
