9 in this paragraph refers to exhibits that any party will present to a  
10 witness for testimonial purposes during the hearing in this matter.

13 The parties shall file and serve on the other parties, their Hearing  
14 Briefs summarizing their arguments concerning contested issues  
15 no later than this date and time.

18 Statements of the Parties; (2) Appellant's Case in Chief; (3)  
19 Interested Party's Case in Chief; (4) The Purchasing Agency's
