ORDER

On February 22, 2016, this matter came before Public Auditor Doris Flores Brooks and Hearing Officer Delia Lujan Wolff for a Hearing. Attorney Kevin J. Fowler appeared on behalf of Appellant Morrico Equipment, LLC (“Morrico”), along with Morrico representative Allan Morrison. Attorney Vanessa L. Williams appeared on behalf of Guam Solid Waste Authority (“GSWA”), along with GSWA representative R. Chace Anderson.

Before proceeding to the Hearing, the Public Auditor orders the following deadlines:

1. The extended deadline for GSWA to file an Agency Report and the procurement record is February 26, 2016. Comments on the Agency Report shall be filed within 10 days after the Public Auditor’s receipt of the Agency Report. Any rebuttal report by GSWA shall be filed within 5 working days after receipt by the Public Auditor of the comments to which the rebuttal is directed.

2. The parties shall file the following materials by the extended deadline of March 17, 2016:

- a. Formal hearing briefs stating the parties’ respective positions supported by applicable authorities;

- b. A statement of stipulated facts;
- c. Witness lists;
- d. Exhibit lists; and
- e. Pre-marked hearing exhibits.

The Hearing on these consolidated appeals is continued to commence at 9:00 a.m., on March 22, 2016, at the Public Auditor’s Hearing Room, Room 907, DNA Building, Hagåtña, Guam.

It is further ordered that GSWA shall serve a copy of this Order upon each other person or company who submitted a bid, in order that any of the other bidders may seek to participate in this appeal as an interested party.

It is further ordered that GSWA shall file with the Public Auditor proof of service of the Order and that it served in accordance with the immediately preceding paragraph. The responsibility to serve a copy of the Order on the other bidders is imposed upon GSWA because it is the entity that is most likely to have the correct names and addresses for such competing bidders.
