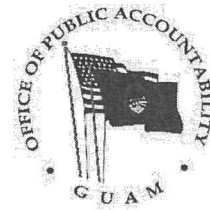

10 separately. The term "Exhibit List" as used in this paragraph refers
11 to exhibits that any party will present to a witness for testimonial
12 purposes during the hearing in this matter.

no later than this date and time.



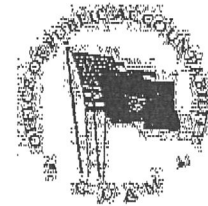
