17 COMES NOW Pacific Data Systems, Inc. ("PDS") and replies as follows to the
18 Response of Guam Community College ("GCC") to PDS's Motion to Enforce Public
19 Auditor's Decision:

20 On April 5, 2011, PDS filed a Motion to Enforce the Public Auditor's Decision.
21 This was because GCC had at that time failed to comply with the Order of the Public
22 Auditor in the Decision of January 12, 2011 that "GCC shall consider the IFB's
23 remaining bidders in accordance with Guam Procurement Law and Regulations."

24 Following the filing of that Motion, GCC did on April 7, 2011, notify the
25 remaining bidders in the subject procurement that all remaining bids were being
26 rejected. PDS has since protested that decision by Protest dated April 21, 2011. As a
27 result, PDS considers its Motion to Enforce Public Auditor's Decision to be moot, and
28 therefore withdraws it.
