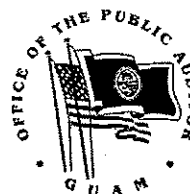



NOTICE IS HEREBY GIVEN that a Pre-Hearing Conference in this matter shall be held before the Hearing Officer for Procurement Appeals at the Office of the Public Auditor on Friday, December 5, 2008 at 10:00 a.m. For the benefit of the parties and their counsel, the Hearing Officer issues the following statement regarding the scheduled Pre-Hearing conference:

The Pre-Hearing Conference will focus on expediting the disposition of the appeal and may include:

- 1 a) Formulation and simplification of issues; Possibility of obtaining admissions of fact
2 and of documents that will avoid unnecessary proof, stipulations regarding the
3 authenticity of documents, and advance rulings from the Hearing Officer on the
4 admissibility of evidence;
- 5 b) The avoidance of unnecessary proof and of cumulative evidence; The identification
6 of witnesses and documents, the need and schedule for filing and exchanging pretrial
7 briefs; The disposition of pending motions;
- 8 c) The need for adopting special procedures for managing potentially difficult or
9 protracted actions, complex issues, multiple parties, or unusual proof problems;
10 Establishing a reasonable limit on the time allowed for presenting evidence; and
- 11 d) Such other matters as may facilitate the just, speedy, and inexpensive disposition of
12 the action.
