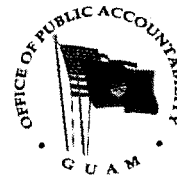

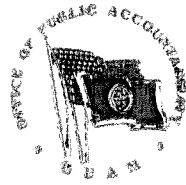

NOTICE IS HEREBY GIVEN, that a Pre-Hearing Conference shall be held before the Public Auditor and Hearing Officer for Procurement Appeals at the Office of Public Accountability, Suite 907, 9th Floor, DNA Building, 238 Archbishop Flores Street, Hagatna, Guam 96910 on Tuesday, April 11, 2017 at 9:00 a.m. For the benefit of the parties and their counsel, the Hearing Officer issues the following statement regarding the scheduled Pre-Hearing conference:

1. The Pre-Hearing Conference will focus on expediting the disposition of the appeal and may include:
 - a. Formulation and simplification of issues;

1 b. Possibility of obtaining admissions of fact and of documents that will avoid
 2 unnecessary proof, stipulations regarding the authenticity of documents, and advance rulings
 3 from the Hearing Officer on the admissibility of evidence;

4 c. The avoidance of unnecessary proof and cumulative evidence;

5 d. The identification of witnesses and documents, the need and schedule for
 6 filing and exchanging pretrial briefs;

7 e. The disposition of pending motions;


8 f. The need for adopting special procedures for managing potentially difficult
 9 or protracted actions, complex issues, multiple parties, or unusual problems;

10 g. Establishing a reasonable limit on time allowed for presenting evidence; and
 11 h. Such other matters as may facilitate the just, speedy, and inexpensive
 12 disposition of the action.

- 13 2. Motion filing Deadline. The Parties shall file and serve on other parties any motions
 14 they may have no later than Monday, April 10, 2017
- 15 3. Any persons requiring special accommodations, auxiliary aids or services to attend the
