2 the Hearing Officer;


3 c) The disposition of pending motions;

4 d) Whether any parties have requested a formal hearing; and

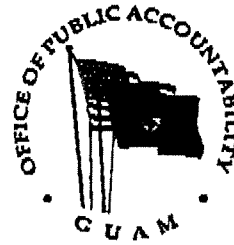
5 e) Such other matters as may facilitate the just, speedy, and inexpensive disposition
