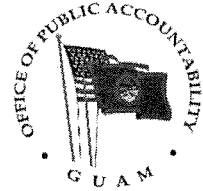

(a) An appeal brief stating the parties' respective positions in this Appeal, containing the portions of the record relied upon and the cases and authorities supporting their positions.


