RECUSAL OF PUBLIC AUDITOR AND ORDER DESIGNATING OPA DEPUTY PUBLIC AUDITOR TO PRESIDE OVER APPEAL

THIS MATTER, came before the Public Auditor on May 4, 2018 pursuant to the Notice of Appeal filed by TakeCare Insurance Company, Inc.. After reviewing the Notice of Appeal, the Public Auditor desires to RECUSE herself from this matter to avoid an appearance of a conflict of interest and, pursuant to 2 G.A.R., Div. 4, Chap. 12, §12116, hereby designates a member of her staff to preside over this matter as follows:

1. Recusal of the Public Auditor. The Public Auditor may recuse herself at any time and notify all the parties. 2 G.A.R., Div. 4, Chap. 12, §12116. Here, the Public Auditor during her bid for re-election for the elected Public Auditor position, received campaign contributions from the President and Legal Counsel of TakeCare Insurance Company, Inc. in 2012. Further, the

Public Auditor received campaign contributions from certain key managers of Calvo's Insurance in 2012 and 2016. The Public Auditor also received campaign contributions from NetCare Life & Health Insurance in 2016. All three insurance companies have a direct involvement in providing health insurance services to the Government of Guam. It shall be a conflict of interest for any employee to assist any person or business or act in a representative capacity before any territorial agency for any compensation in any transaction involving the Territory. 4 G.C.A. § 15205 (c).

Here, the Public Auditor finds that as a candidate in the 2012 and 2016 elections for Public Auditor, she received campaigned contributions from the Appellant and other insurance companies directly involved with the procurement for health insurance services to the Government of Guam's Group Health Insurance Program. Here, the Public Auditor finds that by virtue of their contributions, and her role as the decision maker in this adjudicatory process for this procurement appeal, even the mere appearance of a conflict of interest may come into question. Public employment is a public trust and public employees, such as the Public Auditor, must discharge their duties impartially so as to assure fair competitive access to governmental procurement and they should conduct themselves in such a manner as to foster public confidence and integrity of Guam's procurement organization. Therefore, based on the foregoing, the Public Auditor desires to recuse herself from this matter due to an appearance of a conflict of interest and shall not participate in it in any direct or indirect manner.

2. Designation of Deputy Public Auditor to Preside Over Appeal. In the event of recusal by the Public Auditor, the Public Auditor shall designate a member of her staff to preside over the matter. 2 G.A.R., Div. 4, Chap. 12, §12116. The Public Auditor hereby DESIGNATES Deputy Public Auditor Yuka Hechanova to preside over this matter.
