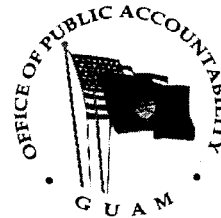

21 §12109(e), hereby FINDS that due to the Public Auditor's resignation from her office that was
22 effective on or about June 22, 2018, and the Guam Election Commission's scheduling the special
23 election for the new Public Auditor on or about August 25, 2018, the Office of Public
24 Accountability (Hereafter referred to as "OPA") is unable to hold the hearing for the Appellant's
25 Appeal scheduled for 9:00 a.m. on July 5, 2018 because there will be no Public Auditor to decide

2 elected and is sworn into office.

4 immediately.


