WHEREAS, TakeCare filed its Reply Brief Re Motion to Dismiss Procurement Appeal on January 4, 2013; and

WHEREAS, as of the date of this filing, a ruling on TakeCare's motion to dismiss by the Office of Public Accountability ("OPA") is pending; and

WHEREAS, should the OPA grant TakeCare's motion to dismiss, then a hearing on this appeal will not be necessary; and

WHEREAS, the parties herein agree that in an effort to avoid spending extensive time, money and resources on a hearing that may not occur, it is in the best interest of all parties to reschedule the aforementioned deadlines; and

WHEREAS, counsel for TakeCare is not available for a hearing until after May 5, 2013; and

WHEREAS, the parties request that the OPA set the Hearing for this appeal on May 7, 9 and 10, 2013.

Now, therefore, the parties herein hereby stipulate and agree that the pending deadlines be continued as follows:


1. Stipulation of Facts and Facts in Dispute: **14 calendar days before the Hearing on the appeal;**


