
1 COMES NOW, the parties herein, by and through their respective counsels and hereby

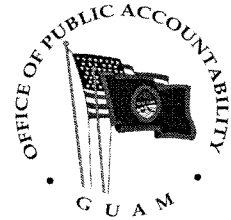
