28 shown, the Hearing Officer hereby ORDERS the following:


1. The Appellant KORANDO CORPORATION shall have until 5:00 p.m. on October 21, 2015 to file its

2. The October 19, 2015 deadline for the Purchasing Agency to file the Procurement Record with the
OPA shall be extended to 12:00 p.m. on October 22, 2015. Additionally, should the Purchasing Agency file any
documents under seal it shall prepare a log of said documents setting forth a brief description of the document and

1 the reason or privilege the Purchasing Agency is asserting to file said document under seal. The Purchasing
2 Agency shall file said log with the OPA and serve a copy of the same on the Appellant no later than 5:00 p.m. on
3 Monday, October 26, 2015.

4 3. The Purchasing Agency shall file its rebuttal to any filed comments on its Agency Report no later than
5 5:00 p.m., on Monday, October 26, 2015 and shall serve a copy of said rebuttal, if any, on the Appellant by that date
6 and time.
