Purchasing Agency Guam Community College ("GCC") respectfully requests correction of a factual error in the Public Auditor's Decision issued August 22, 2016 ("Decision") and issuance of the proposed order that GCC filed on August 16, 2016.

In pertinent part, page 14 of the Decision states:

*On August 11, 2016, the Public Auditor attempted to verify whether WSI actually qualified for the local procurement preference by requesting that GCC provide the Public Auditor with the residential addresses and citizenship of the individuals identified in WSI's bid. On August 16, 2016, GCC only provided the residential addresses of the individuals. Here, the Public Auditor finds that GCC does not have the citizenship information of WSI's employees that it would need to determine whether WSI qualifies for the local procurement preference.*

(Dec. at 14, ll. 2-6 (italics added).)

The above-italicized sentences are in error because GCC's Response to the Request for Additional Information ("Response") provides the citizenship information that the Public Auditor requested and states that WSI informed its employees are citizens of the United States. (See Purch'g Agency's Resp. to Rqst. for Add'l Info. (Aug. 16, 2016) at 2.)

Additionally, in its Response, GCC relayed WSI's request that its employees' residential addresses be kept confidential and submitted these residential addresses as an under-seal exhibit with the Response. (*See Purch'g Agency's Resp. to Rqst. for Add'l Info.* (Aug. 16, 2016) at 1-2; *id.* at Ex. A.) GCC also contemporaneously filed a proposed order regarding these residential addresses submitted under seal, which has not yet been signed and issued by the Public Auditor. (*See Purch'g Agency's [Proposed] Order re Ex. A Submitted Under Seal* (Aug. 16, 2016).)

Accordingly, GCC respectfully requests that the Public Auditor amend the Decision to correct the above-noted factual error and also issue the proposed order regarding the residential addresses submitted under seal.
