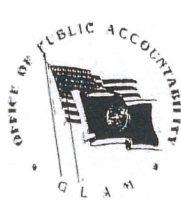

30 **THIS MATTER**, came before the Hearing Officer for a Motion Hearing on August 11,
31 2016. Ho S. Eun appeared on behalf of the Appellant and was represented by the Appellant's
32 Counsel of Record Joyce C.H. Tang, Esq. The Purchasing Agency was represented by Assistant
33 Attorney General Shannon J. Taitano, Esq. Sean Easter was present on behalf of the Interested

1 Party and was represented by Janalynn Cruz Damian, Esq. After hearing the arguments of the
2 parties and for good cause shown, the Hearing Officer hereby ORDERS the following:

3 1. The Appellant's Request to Consolidate its Appeals in OPA-PA-16-007 and OPA-
4 PA-16-011 is hereby GRANTED. There was no opposition from the other parties and the
5 Hearing Officer finds that the Parties, the Procurement Record, and the witnesses in both cases
6 are identical and that consolidation of OPA-PA-16-007 and OPA-PA-16-011 is in the interests of
7 Judicial Economy and the furtherance of achieving an expeditious resolution of these matters.

8 2. The Parties shall adhere to the following revised expedited briefing schedule:

9 a. Supplemental Procurement Record. The Purchasing Agency shall not be
10 required to file a second procurement record, but shall supplement the procurement record it has
11 filed in OPA-PA-16-007 to include any and all correspondence and additional documents
12 concerning the Appellant's July 15, 2016 Protest and the Purchasing Agency's August 3, 2016
13 denial of said protest. The Purchasing Agency shall file said Supplemental Procurement Record
14 no later than 5:00 p.m., August 24, 2016.

15 b. Supplemental Agency Report. The Purchasing Agency shall file a
16 Supplemental Agency Report concerning the Appellant's allegations in OPA-PA-16-011 and
17 serve it on the other parties no later than 5:00 p.m. on August 26, 2016. Oppositions.

18 c. Comments to the Supplemental Agency Report. The Appellant and the
19 Interested Party may comment file their Comments to the Supplemental Agency Report and
20 serve said comments to the other parties no later than 5:00 p.m., on September 2, 2016.

21 d. Rebuttal to Comments on the Supplemental Agency Report. The Purchasing
22 shall file its Rebuttal to Comments on the Supplemental Agency Report, if any, and serve said
23 rebuttal on the other parties no later than 5:00 p.m., on September 6, 2016.
