21	On September 20, 2023, ASC Trust, LLC ("ASC") filed a Notice of Appeal with the Office					
22	of Public Accountability ("OPA"), wherein ASC appeals the decision of purchasing agency					
23	Government of Guam Retirement Fund ("GGRF"), dated September 5, 2023, related to the					
24	procurement for Plan Administration Services related to the Defined Retirement System (401(a)					
25	Plan) Deferred Compensation Plan and Welfare Benefit Plan (GGRF RFP-002-22) ("the RFP").					
2627	The appeal was docketed as OPA-PA-23-005.					

On October 13, 2023, ASC filed another Notice of Appeal, docketed as OPA-PA-23-006, appealing GGRF's decision dated September 29, 2023, denying ASC's second protest related to the RFP.

On October 27, 2023, a Pre-Hearing Conference was held for OPA-PA-23-005, where the parties stipulated to consolidate the two appeals. In addition, the parties filed a stipulated Motion to Consolidate.

The Public Auditor has the authority to consolidate appeals for purposes including efficiency and expediency in resolving appeals. 5 G.C.A. § 5701; 2 G.A.R. §§ 12101, 12108-12109. As these two appeals arise from protests by ASC pertaining to the same RFP by GGRF, the Public Auditor finds that consolidating these appeals will provide for efficient, expeditious resolution of the appeals. Therefore, the Public Auditor ORDERS that these appeals, OPA-PA-23-005 and OPA-PA-23-006, be and are consolidated and all matters pertaining to the appeals shall be heard concurrently.
