such documents separately. The term "Exhibit List" as used in this
paragraph refers to exhibits that any party will present to a witness
for testimonial purposes during the hearing in this matter.

10 **Filing Deadline for**

June 25, 2012 at 5:00 P.M.

12 The parties shall file and serve on the other parties, their Hearing
13 Briefs summarizing their arguments concerning contested issues
no later than this date and time.

14 **Hearing Date:**

July 2, 2012 at 9:00 A.M.

(Notice to issue no later than ten days prior – June 22, 2012)


15 The Hearing will proceed in the following order: (1) Opening
