### ABOUT GALC

The Guam Ancestral Lands Commission (GALC) was created by Public Law 25-45 to serve as the conduit for conveying returned federal excess lands to their original land owners. GALC is known as the Land Claims Facilitator. In 2012, GALC merged into the Department of Land Management through Reorganization Advisory No. 9.

### **OUR MISSION**

Administer the Guam Ancestral Lands Act in order that ancestral landowners, their heirs and descendants may expeditiously exercise all the fundamental civil rights in the property they own; establish a land bank to provide just compensation for dispossessed ancestral landowners; and when appropriate, assume the role of Claims Facilitator to assist ancestral landowners in pursuit of just remedies. ## **FY2018 PROGRESS**


At the year-end September 30, 2018, GALC operated with a board of seven members and one classified employee. With the assistance of Department of Land Management, GALC returned two properties. The two properties are Lot 201 located in the Municipality of Piti, containing an area of 36,208 +\- square meters and Lot 5294 located in the Municipality of Barrigada containing an area of 20,979 +/- square meters. The returned properties increased GALC's aggregate amount of land returned to 2,637.94 acres.

For Fiscal Year 2018, Independent Auditors, Deloitte and Touche, LLP issued an unmodified "clean" opinion on GALC's financial statements, and the report on compliance and internal controls. GALC did not have any findings, and Independent Auditors did not identify any deficiencies in internal control.



## **Future Challenges**

GALC continues to struggle with providing easements to returned property. This is attributed to the lack of financial resources to pay for services and the unwillingness of property owners to dedicate a relatively small portion of their property for easement.

## Outlook

The Executive Director and GALC Commissioners will continue dialogue with the Administration and the Guam Legislature to address concerns of the Attorney General's office related to the Land Bank Rules and Regulations.
