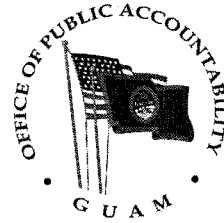

Order After Hearing/ Scheduling Order

On August 26, 2013, a Prehearing Conference was heard before Public Auditor Doris Flores Brooks and Hearing Officer Peter C. Perez, Esq. Joshua D. Walsh, Esq. and Joseph C. Razzano, Esq. appeared with Appellant representative, John R. Ilaio, on behalf of JMI-Edison. Andrew T. Perez, Esq. with Agency representative, Marcus Pido appeared on behalf of GDOE. Seth Forman, Esq. appeared with Interested Party representative, Gene Bangayan, on behalf of Phil-Gets (Guam) International Trading Corp. dba J & B Modern Tech. The Public Auditor ORDERS:

- e. Pre-marked hearing exhibits.
- 6. The hearing on this appeal shall commence at 9:00 a.m., Tuesday, September 24, 2013, at the Public Auditor's hearing room, Room 907, DNA Building, Hagatna, Guam.
- 7. It is further ordered that GDOE shall serve a copy of this Order After Hearing/Scheduling Order upon each other person or company who submitted a bid, in order that any one of the other bidders may seek to participate in this appeal as an interested party.
- 8. It is ordered that GDOE file with the Public Auditor a proof of service of the Order After Hearing/Scheduling Order and that it served in accordance with the immediately preceding paragraph. The responsibility to serve a copy of the Order After Hearing/Scheduling Order on the other bidders is imposed upon GDOE because it is the entity that is most likely to have the correct names and addresses for such competing bidders.
