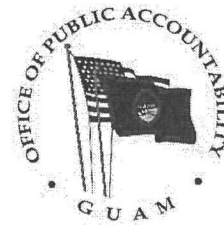

THIS MATTER, came before the Hearing Officer for a Status Conference on April 18, 2016. The Purchasing Agency was represented by its Counsel of Record, REBECCA J. WRIGHTSON, ESQ. RHAJ SHARMA appeared on behalf of the Appellant and was represented by Appellant's Counsel of Record, JOHN R.B. BELL, ESQ. After hearing the statements of the parties and for good cause shown, the Hearing Officer hereby **ORDERS** the following:

1. **Deadline to File Motions to Recuse or Disqualify the Public Auditor.** The Parties shall have until 5:00 p.m. on April 22, 2016 to file and serve on the other party, any motions to recuse or disqualify the Public Auditor from hearing and deciding this matter.

1 2. Briefing and Hearing Schedule. The Briefing and Hearing Schedule for the
2 Purchasing Agency's Motion for Expeditious Disposition (Dismissal) on the Merits filed I this
3 matter on April 15, 2016 shall be as follows:

4 a. Oppositions. Any oppositions to the motion shall be filed and served on the
5 other party no later than 5:00 p.m., on May 6, 2016.

6 b. Reply. Any reply to any oppositions shall be filed and served on the other
7 party no later than 5:00 p.m. on May 13, 2016.

8 c. Hearing. The hearing on the motion shall be held at 10:00 a.m., on May 20,
9 2016.

10 3. Procurement Record. The Purchasing Agency shall supplement the procurement
11 record in this matter by filing, under seal, any and all trade secrets, proprietary data, and
12 confidential data in the procurement record in this matter with the Office of Public
13 Accountability (OPA) no later than 5:00 p.m. on May 6, 2016. The Purchasing Agency shall
14 contemporaneously file and serve on the Appellant a log of any such records filed with the OPA
15 that includes a brief description of such records filed under seal with the OPA.
