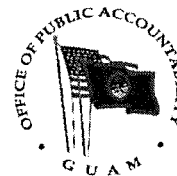

**ORDER**

Appellant Phil-Gets (Guam) International Trading Corp. dba J&B Modern Tech's ("J&B") appeal and Purchasing Agency Guam Community College's ("GCC") Motion for Expeditious Dismissal shall be determined as follows:

1. J&B's unopposed withdrawal of its request for a hearing on the merits of its appeal is GRANTED.
2. The parties are ordered to submit the following:
  - (a) The parties shall file their respective appeal briefs no later than May 10, 2017. In its appeal brief, GCC should also address the present bases upon which it's asserts dismissal should be granted.
  - (b) The parties shall file responses to the respective briefs no later than May 17, 2017. In its response brief, J&B should also address GCC's present arguments in support of dismissal.
3. A ruling on GCC's Motion for Expeditious Dismissal which was heard and taken under advisement on May 1, 2017 will be held in abeyance pending the parties' filings.
4. Unless the parties object in writing no later than May 17, 2017, the Public Auditor may consider the entire record filed in this appeal.
