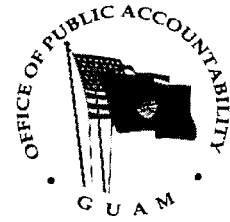

25 **THIS MATTER** came before the hearing officer pursuant to the Appellant's March 6,
26 2018 Motion to Extend the time to File Comments to the Agency Report and Continue further
27 dates. After reviewing the aforementioned motion, and after confirming the Purchasing
28 Agency's Supplementation of the Procurement Record on March 2, 2018, the Hearing Officer
FINDS and ORDERS as follows:

1 1. The Purchasing Agency substantially complied with the February 28, 2018 deadline to
2 supplement the procurement record set forth in the Office of Public Accountability's (OPA)
3 February 26, 2018 Decision and Order that granted the Appellant's Motion to Supplement the
4 Record by completing the supplementation of the procurement record in this matter on March 2,
5 2018.

6 2. The Supplemented Procurement Record is voluminous and contains hard copies and
7 electronic copies of thousands of pages of documents and the existing deadlines in this matter do
8 not give the parties sufficient time to review the extensive procurement record.

9 3. Accordingly, the Appellant's March 6, 2018 Motion to Extend the time to File
10 Comments to the Agency Report and Continue further dates is hereby GRANTED.


11 4. The March 7, 2018 deadline for the Appellant to file its Comments on the Agency
12 Report is hereby extended to March 21, 2018 and the Appellant shall file and serve said
13 comments on the Purchasing Agency no later than 5:00 p.m. on that date.

14 5. The Purchasing Agency shall file its Rebuttal to the Appellant's Comments on the
15 Agency Report, if any, and serve it upon the Appellant no later than 5:00 p.m. on March 28,
16 2018.

17 6. The filing deadlines set forth in the OPAs February 22, 2018 Scheduling Order are
18 hereby VACATED and an Amended Scheduling Order shall issue with extended deadlines.

19 7. The April 9, 2018 Hearing for the Appellant's appeal is hereby rescheduled to April
20 23, 2018 at 9:00 a.m. and a notice concerning this hearing shall issue.

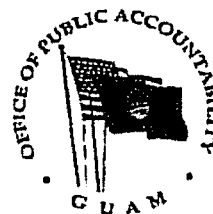
