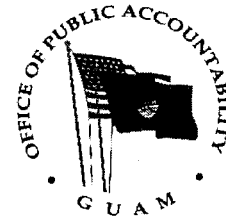


25 **THIS MATTER** came before the Hearing Officer pursuant to the Appellant's Objection
26 to the Purchasing Agency's Notice of Interested Parties filed on February 9, 2018 in this matter.
27 After reviewing the pleadings filed by the parties and after considering the arguments of the
28 parties concerning the aforementioned objection that were given at Pre-Hearing Conference that
was held in this matter on February 12, 2018, the Hearing Officer hereby FINDS and ORDERS
as follows:

1. The Appellant's Objection is now moot. The Appellant's objection is based on the
Purchasing Agency's January 24, 2018 Notice of Interested Parties which identified PARSONS
TRANSPORTATION GROUP and WSP f/n/a PARSONS BRINKEROFF as interested parties
in this matter. However, during the February 12, 2018 Pre-Hearing Conference, the Purchasing

1 Agency explained that it was not representing either of these two entities and was not making an
2 entry of appearance for them in this matter. Additionally, on February 16, 2018, the Purchasing
3 Agency withdrew its identification of PARSONS TRANSPORTATION GROUP and WSP f/n/a
4 PARSONS BRINKEROFF as interested parties in this matter.

5 2. The Hearing Officer also finds that neither PARSONS TRANSPORTATION GROUP
6 or WSP f/n/a PARSONS BRINKEROFF has entered their appearance as interested parties in this
7 matter. Accordingly, the Appellant's Objection is now moot and will be given no further
8 consideration in this matter.
