17 On February 16, 2018, Department of Public Works ("DPW") filed its Response to Appellant  
18 Korando Corporation's ("Korando") Request for Supplementation of Procurement Record and to  
19 Extend the Time to File Comments to Agency Report ("Response"). In its Response, DPW stated that  
20 it would produce additional Procurement Records in the following days, and that it does not object to  
21 the request for additional time to respond to the Agency Report. On February 22, 2018, DPW served  
22 Korando with over two thousands of pages of documents as well as two CDs. Additionally, on  
23 February 23, 2018, counsel for DPW notified counsel for Korando that DPW would produce a  
24 Supplement to the Procurement Record later that day, and would also supplement its production  
25 again in the week of February 26, 2018.
