**STIPULATION AND ORDER RE:

16 Appellant Korando Corporation (“Korando”) and the Department of Public Works (“DPW”),
17 by and through their respective undersigned counsel, hereby jointly submit this Stipulation and Order
18 re: Motion to Compel.

19 The parties stipulate as follows:

- 20 1. Korando filed a Motion to Compel and for Sanctions on March 19, 2018. DPW filed its
21 Response to Korando’s Motion to Compel on March 30, 2018. Oral argument on the
22 Motion to Compel occurred on April 17, 2018. The Public Auditor and Hearing Officer
23 took the matter under advisement.
- 24 2. Following the April 17, 2018 hearing, the parties communicated at length in an effort to
25 resolve their discovery dispute as suggested by the Public Auditor.
- 26 3. DPW cooperated with Korando regarding locating and producing Korando’s requested
27 material, culminating in the supplementation of the procurement record on May 4, 2018.
- 28 4. Although production of some material remains pending, Korando agrees that DPW has



cooperated substantially in the production of requested material. The parties agree to cooperate further in the production of outstanding procurement record documents, as further need arises.


