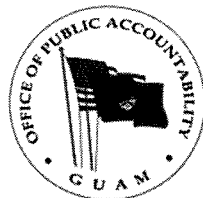

5 c. The avoidance of unnecessary proof and cumulative evidence;

6 d. The identification of witnesses and documents, the need and schedule for
7 filing and exchanging pretrial briefs;

8 e. The disposition of pending motions;

9 f. The need for adopting special procedures for managing potentially difficult
10 or protracted actions, complex issues, multiple parties, or unusual problems;

11 g. Establishing a reasonable limit on time allowed for presenting evidence; and

12 h. Such other matters as may facilitate the just, speedy, and inexpensive
13 disposition of the action.
