# 2023 CITIZEN CENTRIC REPORT



## **ABOUT THE GUAM PUBLIC UTILITIES COMMISSION [PUC]**

- An Independent regulatory commission, separate from the Executive and Legislative Branches, created by Federal Law.
- Governed by seven commissioners who serve six-terms under the appointment by the Governor and confirmation by the Legislature.
- Regulates the rates and rate impacting procurements of Guam Power Authority, Guam Waterworks Authority, the Guam Solida Waste Authority, the Port Authority of Guam, and the Guam International Country Club (Guam Municipal Golf Course).
- Tariff and rate setting, and regulatory duties, for telecommunication companies, including the E911 Surcharge.

## MISSION

The PUC sets rates for ratepayers that are "just and reasonable"; utilities must establish that the Rates charged are based upon the reasonable cost of service. The PUC conducts a hearing process that protects the fundamental rights of the Ratepayers. The PUC must also establish rates that are adequate to cover the full cost of the utilities in providing such service.

## **RATEPAYERS BILL OF RIGHTS**

When a utility seeks a rate increase, the PUC must conduct proceedings in accordance with the rights of ratepayers under the Ratepayer Bill of Rights. The fundamental rights of the Ratepayers include:

- The right to receive clear and adequate notice of any proposed rate increase;
- the right to be fully informed about and to fully evaluate any proposed rate increase, as well as the finances of the Public Utility: and
- the right to give input and participate in any proposed rate increase. Three Public Hearings are held for each rate increase; one each in the Central, Northern and Southern villages.



# HOW WE HAVE PROGRESSED



#### Administrative Budget

The administrative budget covers the Commission's administrative expenses, including staff, office facilities, Commissioner Stipends and training, professional fees, and other operational expenses.

PUC is classified as another stand-alone governmental unit, not a component unit of GovGuam, and therefore is not included in the annual GovGuam audits. ### **Operational Expenses**

PUC operational expenses can be divided into two categories and are budgeted and collected as follows: General administrative expenses, which are budgeted each fiscal year by PUC and divided and assessed among the regulated utilities. **Regulatory expenses, which are incurred pursuant to a Commission resolution, dated August 13, 2007. This expense includes professional and out-of-pocket expenses,** which are billed to specific utilities under regulatory dockets assigned to them to cover the expense of handling specific regulatory proceedings related to them.

## **OUTLOOK and CHALLENGES AHEAD**

#### **Major PUC Actions in FY2023**

• PUC provided supportive testimony for Bill No. 351-36, endorsing the implementation of a Virtual Power Plant Program (VPPP) and emphasizing the benefits of diversifying solar generation sources for Guam rate-payers.

• submitted opposing testimony for Bill 208-36, emphasizing the PUC's responsibility and independent rate-making authority as established by the Organic Act and Guam Laws for Guam rate payers.

• approved GPA's goal to build a 50-megawatt renewable plant on the U.S. Navy land to enhance renewable energy and reduce costs to ratepayers.

• maintain the Levelized Energy Adjustment Clause [LEAC] for the period from February 1, 2023 to July 31, 2023.

• GWA sought PUC approval for the reallocation of GWA's Series 2020A bond proceeds (\$103 million) which aimed to secure additional funding for court-ordered repair, etc. and projects related to reservoir tanks, inspection and request replacement design of water and sewer utilities crossing bridges. This request followed a prior allocation for \$30,425,000.

• approved GWA Annual True-up for FY23 at a rate of 16.7 percent for GWA instead of the initially proposed 16.1 percent this decision followed a comprehensive overview by Chief ALJ Horecky, who highlighted GWA's substantial request for a \$28 million increase, the largest in PUC true-up history.

• it was necessary to approve and to accommodate contract amount surpassing GSWA's \$750,000 threshold. Given its limited operational of garbage trucks; it was deemed essential.

• PUC moved to approve the Chairman's order and authorized the additional amount of \$23,115.98, resulting in a revised total cost of \$1,379,969.98 for the GSWA trucks.

#### **PUC's Outlook**

In FY2023, the PUC has actively engaged in the review of proposed bills, contributing valuable testimony to the Guam Legislature.

PUC is eager to collaborate with both the Executive and Legislative branches of our government to enact legislation that enhances the efficiency of Guam's utilities. As an ongoing commitment, the PUC remains ready to provide valuable insights to the Legislative branch on any proposed legislation that may impact the utilities and rate payers of Guam.

PUC anticipates that its scope of work will increase in the upcoming fiscal year with possible rate increase requests from several utilities. In the course of its regulatory duties over the past year, the PUC has noted that the operational costs of the utilities have increased substantially due to inflation and other factors. These increased costs could place pressure on the utilities to seek rate increases.

#### **COMMISSIONERS POSITION**

The membership of the Commission is comprised as follows:

2-members from the Business Community,2members from the Community, 1-member who is Certified Public Accountant and 2-members (each whom have training and experience in at least one of the following areas: Power generation, telephone, water/sewer utilities, or (marine terminal operations/transportation via ocean common carrier) with an additional requirement that the two members have training or experience in different areas.
