16 Interested Party<sup>1</sup> Docomo Pacific, Inc. (“Docomo”) hereby requests additional time to  
17 submit comments to Guam Power Authority’s (“GPA”) Statement Answering Allegations of  
18 Appeal (“Answer”) filed with the Office of Public Accountability on December 24, 2014.  
19 Pursuant to 2 GAR Div. 4 Section 12104(c)(4), Appellant and Interested Parties may submit  
20 comments on GPA’s Agency Report, which includes its Answer, within ten (10) days of the Public  
21 Auditor’s receipt of the report. Thus, the deadline to file any comments to GPA’s Answer is  
22 January 5, 2015.<sup>2</sup>

23 Docomo, however, never received formal notice of this appeal as required 2 GAR Div. 4  
24 Section 12014(c)(2).

26 issued by Guam Power Authority on November 14, 2014, thus Docomo is an Interested Party. 2  
27 GAR Div. 4 Section 12102(b) (“Interested Party means an actual or prospective bidder, offeror, or  
28 contractor who appears to have a substantial and reasonable prospect of receiving an award if the  
Appeal is denied.”).


